



DUMPSTER RENTAL AGREEMENT

Payment is due upon delivery of the container. Any additional fees due to overweight or other fees not paid upon delivery are due within 14 days of container pick up. Cancellation fees will apply for any dumpster canceled with less than 48 hours notice.

Dumpster Use

Unless specific arrangements have been made, your dumpster can arrive any time throughout your scheduled day. The dumpster will be picked up at the end of the last scheduled day, or the morning after.

The following items are NOT allowed in the dumpster:

- **Organic Waste (dirt, concrete, tree stumps, bricks, rocks, stones, sand, etc.)**
- **Shingles**
- **Hazardous Waste (flammable liquids, paint, oil, gas, tires, etc.)**
- **Medical Waste or animal carcasses of any kind**
- **Batteries**
- **Appliances (tv's, air conditioners, electronics, refrigerator, etc.)**
- **Mattresses/Box Springs of any size**

If the above prohibited materials are found in the dumpster, additional charges will apply.

Due to strict weight limitations and associated dump/landfill fees, loads exceeding the 3000 lb limit will be billed at \$10 per 100lb overage. Excess weight may result in strain or damage to driveway/drop-off location.

The dumpster must not exceed "water level". If the dumpster has been overloaded and items are placed over the top, pick up may not be possible. Midwest Dumpster Rentals LLC is not responsible for items that fall out of the dumpster and cause damage. If the dumpster is unable to be picked up due to being overloaded, there will be a \$150 turn-around charge for coming back.

Customers will be liable for any loss or damage to rented equipment more than reasonable wear and tear.

Access & Ground Conditions

The Customer will be responsible for the provision of free and suitable access to and from the delivery site (including the removal and reinstatement of local obstructions) and for ensuring suitable ground conditions for delivery, placement and removal of the dumpster. Midwest Dumpster Rentals LLC will not be responsible for any damage to your property, including any surface and Customer should therefore take steps to protect surfaces (e.g. paving slabs, soft ground) before delivery. If the delivery location is not accessible when we arrive to drop off the dumpster, or, if the dumpster is blocked on the scheduled pickup day, and we cannot remove the dumpster, there will be a \$150 turn-around charge for coming back.

Should the container cause damage to concrete or asphalt during loading or unloading or any injuries result from said dumpster, Midwest Dumpster Rentals LCC shall not be held responsible, and Customer agrees to hold harmless and indemnify Midwest Dumpster Rentals LCC from any and all claims or causes or actions relating to the dumpster and/or services provided to Customer.

In the case of severe weather, or in the event of ice and/or snow, we may not be able to pick up and/or deliver your dumpster at the scheduled time.
